Zoning	The Zoning Ordinance designates land use zones including Open Space to designate lands in public or private ownership that are essentially unimproved and should remain in open space use for the preservation of identified scenic values, habitat for endangered plants or animals, unique geologic features, natural resources, passive recreational values, or for the protection of public health and safety. Natural Resource zones contain productive or potentially productive petroleum, mineral or timber resources. Scenic Corridors designate areas that contain unique visual and scenic resources as viewed from a major highway or freeway wherein the siting of off-site advertising signs needs to be reviewed on a case-by-case basis to safeguard the scenic qualities of the natural environment. RIPARIAN VEGETATION: Development on hillsides shall respect the natural terrain and to the maximum extent possible preserve all natural drainage courses containing significant perennial vegetation in their natural state. Subdivision,	In the event a subdivision is traversed by a river, stream or creek, the subdivider shall leave such river, stream or creek in its

An exception is made for additions, of less than a 50% increase in square footage. The H.M.F. is for land acquisition, land endowment, habitat management land improvement, public facilities mitigation, and administration of the HCP program. A property owner may transfer title to land in-lieu of payment of a portion of the HMF. The implementation trust shall not accept land that does not, in its sole discretion, represent essentially the same habitat and support the same endangered plant and/or animal species as the project site requiring mitigation without the written approval of CDFG and USFWS. Permittees must allow access to parcels containing known kit fox dens by CDFG and USFWS 5 days prior to ground disturbance activities to allow salvage.
